BOARD OF EDUCATION VIRTUAL MEETING

CENTER MORICHES, NY APRIL 1, 2020

The Board of Education, Center Moriches Union Free School District, held a Virtual Regular Meeting on Wednesday, April 1, 2020 at 6:00 p.m. Those participating were Board Members George Maxwell, Danielle Dench, Marcus Babzien, Joshua Foster and Thomas Kelly; Superintendent Ronald Masera, Assistant Superintendent Raina Ingoglia, Assistant Superintendent Keri Loughlin and Assistant Superintendent Ricardo Soto.

On motion by Mrs. Dench, seconded by Mr. Babzien and carried 5-0, the Board voted to enter into Executive Session at 6:08 p.m. for the purpose of contract negotiations with the CMTA and Teamsters Union.

On motion by Mrs. Dench, seconded by Mr.Foster and carried 5-0, the Board voted to adjourn the Executive Session and return to the Regular Meeting at 7:28 p.m. District Clerk Patricia A. Galietta joined the meeting at 7:28p.m.

President Maxwell resumed the meeting with the Pledge of Allegiance. There were 42 members of the community viewing the virtual meeting. President Maxwell thanked members of the community, administration, members of the faculty, and support staff for their efforts during this difficult time.

1. Superintendent's Report

- COVID-19 Update/Distance Learning Update Dr. Masera updated the Board on the progress with the distance learning program, distribution of chromebooks to the students and emphasizing the importance of students having a connection to the school, making efforts to ensure the no one (students, faculty and staff) is left behind.
- 2020-2021 Budget Workshop #4 Ms. Loughlin reported that expenses will be less, due to the closure of the schools, but that state aid will be less than anticipated and that the budget process is continuing. The date of the Annual Budget Vote and Election has been postponed to the beginning of June, but details are still unclear about the procedures that will be in place.

WHEREAS, the Non-aligned Employees do not have collective bargaining agreements and, therefore, have their terms and conditions of employment established by action of the Board of Education; and

WHEREAS, on March 15, 2020, Governor Andrew Cuomo issued Executive Order 202.4, which mandates that effective March 17, 2020 through April 15, 2020, the District must allow non-essential personnel to be able to work from home or take leave without charging accruals, except for those personnel essential to the District's response to the COVID-19 emergency, and such non-essential personnel shall total no less than 50% of the total number of employees across the District's entire workforce; and

NOW, THEREFORE, BE IT RESOLVED, that pursuant to New York General Municipal Law Section 92 and Executive Order 202.4, the Board shall provide paid leave to all non-essential non-aligned employees on regularly scheduled workdays, at their regular rates of pay, who are ready, willing and able to work as determined by the Superintendent of Schools during the period that Executive Order 202.4 remains in effect and any period that extends the effect of Executive Order 202.4; and

BE IT FURTHER RESOLVED, all essential personnel who are ready, willing and able to work as determined by the Superintendent of Schools shall perform such duties within the scope of their title during the period that Executive Order 202.4 remains in effect and any period that extends the effect of Executive Order 202.4 whether remotely and/or in the District.
