The Board of Education, Center Moriches Union Free School District, held a Regular Meeting in the Board Room on Wednesday, April 18, 2012 at 7:00 p.m. Those present were Board Members Joseph W. McHeffey, Wendy R. Turkington, Daniel Finnegan, Thomas R. Hogan and Heather Schaub-Magill; Superintendent Russell J. Stewart, Business Official Carol M. Perkins, District Treasurer Diane M. Smith and District Clerk Patricia A. Galietta.

President McHeffey called the Regular Meeting to order at 7:09 p.m. with the Pledge of Allegiance. There were 19 visitors present

1. Superintendent's Report

6. **Budget Adoption – 2012-2013**

Upon the recommendation of the Superintendent of Schools, and on motion by Mrs. Turkington, seconded by Mr. Finnegan and carried 5-0, the Board of Education voted to adopt the 2012-2013 proposed school district budget (Proposition #1) in the amount of \$39,426,038.

Adoption of this budget requires a tax-levy increase of 4.90%, which exceeds the statutory tax-levy increase limit of 2.95% of this school fiscal year, and, therefore, exceeds the state tax cap and must be approved by sixty percent of the qualified voters present and voting.

7. <u>Transportation - Proposition #2</u>

Upon the recommendation of the Superintendent of Schools, and on motion by Mrs. Turkington, seconded by Mr. Finnegan and carried 5-0, the Board of Education of the Center Moriches Union Free School District is hereby authorized and required to <u>continue to provide unlimited</u> transportation for the 2012-2013 school year to all students.

A vote of "yes" on this proposition means that the transportation guidelines shall continue as currently provided and will be as follows:

Transportation will be provided to all students for the 2012-2013 school year.

A vote of "no" on this proposition means that for the 2012-2013 school year, transportation will only be provided as required by state mandates as follows:

- Transportation will be provided for students in Grades K 8 residing more than 2 miles, but not more than 15 miles from their school; and
- Transportation will be provided for students in Grades 9 12 residing more than 3 miles, but not more than 15 miles from their school.

If the "no" vote prevails, the estimated annual savings in transportation costs after the allotment of state aid is \$322,800.

8. **Property Tax Report Card**

Upon the recommendation of the Superintendent of Schools, and on motion by Mrs. Turkington, seconded by Mr. Finnegan and carried 5-0, the Board of Education voted to approve the following resolution:

BE IT HEREBY RESOLVED THAT the Board of Education of the Center Moriches Union Free School District approve the real property tax report card prepared by the district's business office for the 2012 Annual District Meeting; and

BE IT FURTHER RESOLVED that a copy of said report card shall be submitted to The State Education Department by the end of the next business day following this approval.

9. <u>Limited Income Disability Exemption</u>

Upon the recommendation of the Superintendent of Schools, and on motion by Mrs. Turkington, seconded by Mr. Finnegan and carried 5-0, the Board of Education voted to authorize the Limited Income Disability Exemption for the 2012 tax year.
