BOARD OF EDUCATION REGULAR MEETING

CENTER MORICHES, NY
MARCH 19, 2015

The Board of Education, Center Moriches Union Free School District, held a Regular Meeting in the High School Large Group Instruction Room on Wednesday, March 19, 2015 at 7:30 p.m. Those present were Board Members Joshua P. Foster, Robyn Rayburn, Wendy R. Turkington and Gary Unger; Superintendent Russell J. Stewart, Business Official Carol M. Perkins, School Attorney Richard Guercio, Treasurer Diane M. Smith and District Clerk Patricia A. Galietta. Board Member Thomas R. Hogan was absent.

President Foster called the Regular Meeting to order at 7:33 p.m. with the Pledge of Allegiance. There were 15 visitors present.

1. Superintendent's Report

- Building and Grounds Five Year Maintenance Plan – Mr. Crowell made a presentation to the Board, highlighting the work that needs to be done, and proposed a 5 year plan for maintenance, repairs and upgrades throughout the district.
- Tax Cap and Revenue – Mr. Stewart and Ms. Perkins reviewed the process the State uses to calculate the tax cap, which for the 2015-16 school year is 4.21%. She also explained that a proposed tax levy increase of 1.37% would result in an increase of \$90.53 per household with an average assessment of \$2700.

**NOTICE OF PUBLIC HEARING, BUDGET VOTE AND ELECTION
OF THE CENTER MORICHES UNION FREE SCHOOL DISTRICT

NOTICE IS HEREBY GIVEN, that a Public Hearing of the qualified voters of the Center Moriches Union Free School District, Center Moriches, Suffolk County, New York, will be held in the Administration Building, Center Moriches Union Free School District, 529 Main Street, Center Moriches, New York, in said District on May 7, 2015, at 7:00 p.m., prevailing time, for the transaction of business as authorized by the Education Law, including the following items:

1. To present to the voters a detailed statement (proposed budget) of the amount of money, which will be required for the 2015-16 fiscal year.
2. To discuss all the items hereinafter set forth to be voted upon by voting machines at the Budget Vote and Election to be held on Tuesday, May 19, 2015.
3. To transact such other business as may properly come before the meeting pursuant to Education Law of the State of New York and acts amendatory thereto.

A copy of the proposed budget shall be made available, upon request, to residents of the school district beginning April 30, 2015, between the hours of 9:00 a.m. and 3:00 p.m., prevailing time, at the Office of District Clerk, Center Moriches High School, 311 Frowein Road, Center Moriches, New York.

AND FURTHER NOTICE IS HEREBY GIVEN, that pursuant to Chapter 258 of the Laws of 2008, Section 495 was added to the Real Property Tax Law, and requires the School District to attach to its proposed budget an exemption report. Said exemption report, which will also become part of the final budget, will show how much of the total assessed value on the final assessment roll used in the budgetary process is exempt from taxation, list every type of exemption granted, identified by statutory authority, and show: (a) the cumulative impact of each type of exemption expressed either as a dollar amount of assessed value or as a percentage of the total assessed value on the roll; (b) the cumulative amount expected to be received from recipients of each type of exemption as payments in lieu of taxes or other payments for municipal services; and (c) the cumulative impact of all exemptions granted. The exemption report shall be posted on any bulletin board maintained by the District for public notices and on any website maintained by the District.

AND FURTHER NOTICE IS HEREBY GIVEN, that said Budget Vote and Election will be held on Tuesday, May 19, 2015, between the hours of 7:00 a.m. and 9:00 p.m., prevailing time, in the gymnasium of the Clayton Huey Elementary School, 511 Main Street, Center Moriches, New York, during which time the polls will be open to vote by voting machine upon the following items:

1. To adopt the annual budget of the School District for the fiscal year 2015-16 and to authorize the requisite portion thereof to be raised by taxation on the taxable property of the District.
2. To elect two (2) members of the Board of Education; one for a for a three-year term commencing July 1, 2015 and expiring on June 30, 2018, and one for the remaining portion of a three year term that commenced on July 1, 2013 and expires on June 30, 2016, with the successful candidate for such unexpired term to take office immediately upon being elected and duly qualified.

- (a) That the Board of Education of the Center Moriches Union Free School District, in the County of Suffolk, New York (the "District"), is hereby authorized to construct additions, alterations and improvements to District school buildings and the sites thereof (the "Project"), substantially as described in the report entitled "Facilities Evaluation – 2014", dated March 19, 2015, prepared for the District by John A. Grillo, Architects, (the "Report"), which report is on file and available for public inspection at the office of the District Clerk; such Project consisting of (as and where required): interior reconstruction and space reconfiguration; roof reconstruction and/or replacement; improvements to lavatories and to the heating, ventilation, air conditioning, electrical, septic, security, fire alarm, clock, and public address systems; window, door, ceiling, and floor replacements; exterior building envelope and track improvements; all of the foregoing to include the original furnishings, equipment, machinery, apparatus and ancillary or related site, demolition and other work required in connection therewith; and to expend therefor, including preliminary costs and costs incidental thereto and to the financing thereof, an amount not to exceed the estimated total cost of ~~\$8,400,961~~ ^{\$8,272,884}; provided that the detailed costs of the components of the Project as set in detail in the Report may be reallocated among such components if the Board of Education shall determine that such reallocation is in the best interests of the District;
- (b) that a tax is hereby voted in the aggregate amount of not to exceed \$8,400,961 to finance said cost, such tax to be levied and collected in installments in such years and in such amounts as may be determined by said Board of Education; and
- (c) that in anticipation of said tax, bonds of the District are hereby authorized to be issued in the aggregate principal amount of not to exceed ~~\$8,400,961~~ ^{8,272,884} and a tax is hereby voted to pay the interest on said bonds as the same shall become due and payable.

AND FURTHER NOTICE IS HEREBY GIVEN, that petitions nominating candidates for the office of member of the Board of Education shall be filed with the Clerk of said School District at the Center Moriches High School, 311 Frowein Rd. , Center Moriches, New York, not later than 5:00 p.m., prevailing time, on April 20, 2015. Vacancies on the Board of Education are not considered separate, specific offices; candidates run at large. Nominating petitions shall not describe any specific vacancy upon the Board for which the candidate is nominated; must be directed to the Clerk of the District; must be signed by at least 25 qualified voters of the District (representing the greater of 25 qualified voters or 2% of the number of voters who voted in the previous annual election); must state the name and residence of each signer, and, the name and residence of the candidate.

AND FURTHER NOTICE IS HEREBY GIVEN, that personal registration of voters is required either pursuant to §2014 of the Education Law or pursuant to Article 5 of the Election Law. AND FURTHER NOTICE IS HEREBY GIVEN, that pursuant to §2014 of the Education Law of the State of New York, the Board of Registration will meet on Tuesday, May 19, 2015, between the hours of 7:00 a.m. and 9:00 p.m., prevailing time, in the gymnasium of the Clayton Huey Elementary School, Center Moriches, New York to prepare the Register of the School District to be used at the Budget Vote and Election to be held in 2016, and any special district meetings that may be held after the preparation of said Register, at which time any person will be entitled to have his or her name placed on such Register provided that at such meeting of said Board of Registration he or she is known or proven to the satisfaction of such Board of Registration to be then or thereafter entitled to vote at the school election for which said Register is prepared, or any special district meeting held after May 19, 2015.

A list of persons to whom absentee ballots are issued will be available for inspection to qualified voters of the District in the Office of the District Clerk, Administration Building, 529 Main Street, Center Moriches, New York, on and after Thursday, May 14, 2015, between the hours of 8:00 a.m. and 3:00 p.m. on weekdays prior to the day set for the annual election and on May 19, 2015, the day set for the election. Any qualified voter then present in the polling place may object to the voting of the ballot upon appropriate grounds by making his/her challenge and the reasons therefore known to the Inspector of Election before the close of the polls.

Grillo, Architects, (the "Report"), which report is on file and available for public inspection at the office of the District Clerk; such Project consisting of (as and where required): interior reconstruction and space reconfiguration; roof reconstruction and/or replacement; improvements to lavatories and to the heating, ventilation, air conditioning, electrical, septic, security, fire alarm, clock, and public address systems; window, door, ceiling, and floor replacements; exterior building envelope and track improvements; all of the foregoing to include the original furnishings, equipment, machinery, apparatus and ancillary or related site, demolition and other work required in connection therewith; and to expend therefor, including preliminary costs and costs incidental thereto and to the financing thereof, an amount not to exceed the estimated total cost of ~~\$8,400,961~~; provided that the detailed costs of the components of the Project as set in detail in the Report may be reallocated among such components if the Board of Education shall determine that such reallocation is in the best interests of the District: 8,272,884

(b) that a tax is hereby voted in the aggregate amount of not to exceed ~~\$8,400,961~~ to finance said cost, such tax to be levied and collected in installments in such years and in such amounts as may be determined by said Board of Education; and 8,272,884

(c) that in anticipation of said tax, bonds of the District are hereby authorized to be issued in the aggregate principal amount of not to exceed ~~\$8,400,961~~ and a tax is hereby voted to pay the interest on said bonds as the same shall become due and payable. 8,272,884
